

## **Terms of Use**

These Terms of Use ("Terms") apply to your submission to and use of the OneTrust Mobile App Privacy Scan ("App Scan") and any other website or service created and provided by OneTrust LLC and its affiliates (collectively, "OneTrust") available for general viewing and use that references these Terms of Use.
